A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO TCL MERCHANDISE BROKERAGE INC. FOR THE SUPPLY & DELIVERY OF VARIOUS OFFICE SUPPLIES FOR THE ALTERNATIVE LEARNING PROGRAM (TABACO CITY LITERACY HUB)
