A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE CATERING SERVICES – MEALS WITH TABLE AND CHAIRS RENTAL FOR THE BUNTIS CONGRESS AND BUNTIS PAGEANT
