A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE, OPC FOR THE SUPPLY & DELIVERY OF SAFETY INSTRUMENTS FOR ABATTOIR OPERATION
