A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO OTILLA MARINE PRODUCTS FOR THE SUPPLY & DELIVERY OF BANGUS FINGERLINGS FOR THE FISHERFOLK ASSOCIATION TABACO CITY MARICULTURE PARK
