A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE JO-LABOR AND MATERIALS FOR THE CHRISTMAS 2024 FUTURISTIC WONDERLAND AT CITY PLAZA, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-10-1473** with an Approved Budget for the Contract (ABC) of **Php 599,967.00**;
