A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JO-LABOR & MATERIALS FOR THE REHAB / REPAIR OF SAN ANTONIO DAY CARE CENTER 3 AT SAN ANTONIO, TABACO CITY
