A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JO-SUPPLY OF LABOR AND MATERIALS FOR THE POST CLOSURE MAINTENANCE OF SAN VICENTE AND SAN ANTONIO CLOSED DUMPSITE FOR THE YEAR 2024
