**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE & CONSTRUCTION SUPPLY FOR SUPPLY & DELIVERY OF HARDWARE MATERIALS AND SUPPLIES FOR THE CHRISTMAS 2024: INSTALLATION OF CHRISTMAS DECORATION (FUTURISTIC WONDERLAND)**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-10-1533** with an Approved Budget for the Contract (ABC) of **Php 589,395.00**;
