**BAC Resolution No. 2024-4Q-12-**

**RECOMMENDING THE AWARD OF CONTRACT TO THE BICOL REGIONAL WEEKLY DIGEST FOR THE PUBLICATION OF VARIOUS CITY ORDINANCE**

**WHEREAS**, on November 27, 2024, the Office of the City Vice Mayor through the SP Secretariat has submitted to the Bids and Awards Committee (BAC) **Purchase Request No. 24-11-1794** requesting the **Publication of Various City Ordinance** with an Approved Budget for the Contract (ABC) in the amount of **One Million Three Hundred Thirty-Five Thousand Three Hundred Ninety-Nine Pesos (Php 1,335,399.00)** sourced from the General Fund 2024;

**WHEREAS**, RA 7160 or the Local Government Code of the Philippines, particularly Sections 59 and 511 thereof, states that publication of ordinances shall be in a newspaper of general circulation within the province where the local legislative body concerned belongs, or within the territorial jurisdiction of the local government unit concerned;

**WHEREAS**, based on the Market Study of the end-user, **The Bicol Regional Weekly Digest** is one of the news publishers with the highest number of government publication contracts in the Province of Albay where the City Government of Tabaco belongs to. The Study also showed that said publisher offers the most advantageous price for the Government;

**WHEREAS**, the Bids and Award Committee has recommended to the City Mayor the use of **Negotiated Procurement (Media Services)** under Sec. 53.6 of the IRR-RA 9184 as the alternative mode of procurement for the foregoing purchase request;

**WHEREAS**, upon approval of the said recommendation, the BAC has sent a Request for Quotation to **The Bicol Regional Weekly Digest**, which was returned before the deadline for submission on December 02, 2024;

**WHEREAS**, the opening and evaluation of the Price Quotation showed that **The Bicol Regional Weekly Digest** offers to provide the required publication services at a contract price amounting to **One Million Two Hundred Seventy-Nine Thousand Seven Hundred Fifty-Six Pesos and Eighty Centavos (Php 1,279,756.80)**;

**WHEREAS**, upon careful review and evaluation of the legal, technical, and financial requirements of **The Bicol Regional Weekly Digest**, the BAC found that it is compliant and responsive with the requirements of the project;

**NOW, THEREFORE**, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor **CIELO KRISSEL BURCE LAGMAN**, the award of the foregoing contract to **The Bicol Regional Weekly Digest** at a contract price amounting to **One Million Two Hundred Seventy-Nine Thousand Seven Hundred Fifty-Six Pesos and Eighty Centavos (Php 1,279,756.80)**.
