A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES AND REPAIR FOR THE SUPPLY & DELIVERY OF IT EQUIPMENT (COMPUTER SERVER), CITY MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 051-12-2024-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the Supply & Delivery of IT Equipment (Computer Server), City Mayor's Office, Tabaco City under Contract ID No. 051-12-2024-GOODS-PB with an Approved Budget for the Contract (ABC) amounting to Six Hundred Twenty-Eight Thousand Pesos (Php 628,000.00) in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on December 12, 2024, the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Albay Computer & Electronics Supplies & Repair*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

a) To declare the bid of ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR as the Lowest Calculated Responsive Bid (LCRB) for the Supply & Delivery of IT Equipment (Computer Server), City Mayor's Office, Tabaco City under Contract ID No. 051-12-2024-GOODS-PB; and

b) To recommend to the City Mayor of Tabaco the award of contract to ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR in the amount of Four Hundred Sixty-Nine Thousand Eight Hundred Pesos (Php 469,800.00).
