A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES AND REPAIR FOR THE SUPPLY & DELIVERY OF IT EQUIPMENT (COMPUTER SERVER), CITY MAYOR’S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 051-12-2024-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of IT Equipment (Computer Server), City Mayor’s Office, Tabaco City under Contract ID No. 051-12-2024-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *Six Hundred Twenty-Eight Thousand Pesos (Php 628,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on December 12, 2024, the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:
