A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MDSE. FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES FOR THE HEALTH IEC CAMPAIGN (MENOPAUSE-INDUCED HYPERTENSION AWARENESS)
