A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO QUALIGEN PHARMACY FOR THE SUPPLY & DELIVERY OF MEDICAL EQUIPMENT


WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
