A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MDSE. FOR THE SUPPLY & DELIVERY OF VARIOUS MEDICAL MATERIALS AND SUPPLIES FOR EMERGENCY SUPPLIES AND EQUIPMENT FOR DIFFERENT DRRM ACTIVITIES
