A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MANZIHING CORPORATION FOR THE SUPPLY & DELIVERY OF VARIOUS VEGETABLE SEEDS FOR HOMES AND SCHOOL FOR BACKYARD GARDENS (FAMILIES WITH UNDERNOURISHED CHILDREN, SCHOOLS AND COMMUNITIES)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-08-1165 with an Approved Budget for the Contract (ABC) of Php 199,930.00;
