BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO RIGHTSIZE EDUCATION TECHNOLOGIES, INC. FOR THE SUBSCRIPTION TO SPLAT SOFTWARE FOR THE SCHOOL DIVISION OFFICE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) has adopted **Direct Contracting** as the mode of procurement for the **Subscription to SPLAT Software for the School Division Office, Tabaco City** under Purchase Request No. **24-10-1396** with an Approved Budget for the Contract (ABC) amounting to **Three Hundred Fifty Thousand pesos (Php 350,000.00)**;

WHEREAS, the BAC directly negotiated the foregoing project with **RIGHTSIZE EDUCATION TECHNOLOGIES, INC.** by requesting the same to submit a price quotation or pro-forma invoice together with the terms and conditions of the sale;

WHEREAS, after the deadline for submission of price quotation, **RIGHTSIZE EDUCATION TECHNOLOGIES, INC.** has offered to supply and deliver the goods at a contract price of **Three Hundred Fifty Thousand pesos (Php 350,000.00)**;

WHEREAS, upon careful examination, validation, and verification of all the documents submitted by **RIGHTSIZE EDUCATION TECHNOLOGIES, INC.** the BAC found that it is technically, legally and financially capable to deliver the goods and services and the price offered is the most advantageous price for the government;

NOW, THEREFORE, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISSEL LAGMAN-LUISTRO**, the award of the foregoing contract to **RIGHTSIZE EDUCATION TECHNOLOGIES, INC.** at a contract price amounting to **Three Hundred Fifty Thousand pesos (Php 350,000.00)**.
