A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS GLOVES AND KITCHEN HAIRNET FOR KITCHEN INSTRUMENTS FOR THE SUPPLEMENTATION OF COMPLEMENTARY FOOD TO 6-23 MONTHS OLD CHILDREN (FEEDING SUPPLEMENTATION) FOR THE PRODUCTION OF COMPLEMENTARY FOODS IN TABACO F1K++ NUTRI CENTER
