A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 3G POWERPLUS 2C CORPORATION FOR THE SUPPLY & DELIVERY OF AMORPHOUS DISTRIBUTION TRANSFORMER FOR THE POWER SUPPLY UPGRADE OF TABACO CITY ABATTOIR AT SAN CARLOS, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement **Purchase Request No. 24-11-1539** with an Approved Budget for the Contract (ABC) of **Php 591,000.00**;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


