### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE & CONSTRUCTION SUPPLY FOR SUPPLY & DELIVERY OF HARDWARE MATERIALS AND SUPPLIES FOR THE REPAIR AND MAINTENANCE OF SCHOOL BUILDING AND OTHER FACILITIES

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1562** with an Approved Budget for the Contract (ABC) of **Php 530,000.00**;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


