A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR THE BARANGAY GAD PLAN AND BUDGET WORKSHOP FOR 2026 AND AR 2024

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


