A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO QUALIGEN PHARMACY FOR THE SUPPLY & DELIVERY OF MEDICAL EQUIPMENT AND SUPPLIES FOR OPERATION TULI 2024

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1591** with an Approved Budget for the Contract (ABC) of **Php 161,704.00**;
