A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 ENTERPRISES FOR THE SUPPLY & DELIVERY OF TOTE BAG AND UMBRELLA TO BE GIVEN AS TOKEN FOR THE NUTRITION PROGRAM ASSESSMENT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1595** with an Approved Budget for the Contract (ABC) of **Php 122,850.00**;
