A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO THEISM FOOD HOUSE FOR THE MEALS FOR 2 DAYS FOR THE ACTIVE TRANSPORT HEALTH PROMOTION PLAYBOOK LAUNCHING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1611** with an Approved Budget for the Contract (ABC) of **Php 106,000.00**;
