A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS & VENUE FOR THE EVALUATION FORUM ON THE YEAR'S IMPLEMENTATION OF TRAINING / SEMINARS UNDER ADOLESCENT HEALTH AND YOUTH DEVELOPMENT PROGRAM
