A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO THEISM FOOD HOUSE FOR THE MEALS FOR THE ANNUAL MEDICAL CONSULTATION OF CHECK-UP OF PUSHERS

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


