A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO M. BARSAGA EATERY FOR THE MEALS FOR THE CAPACITY BUILDING AND SKILLS TRAINING (TRAINING ON MRF AND SLF OPERATION CUM ORIENTATION ON BASIC OCCUPATIONAL HEALTH AND SAFETY, AND SANITATION PRACTICES

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


