### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS FOR VEHICLES WITH PLATE NO. NGF-3221 AND F4J-884 AND LONKING BACKHOE

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1667** with an Approved Budget for the Contract (ABC) of **Php 56,068.70**;
