A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS AND ACCESSORIES FOR VEHICLE WITH PLATE NO. / CONDUCTION STICKER D2C-830, AND SAB-1679 (HOWO) AND GENERATOR SET AND OTHER SUPPLIES FOR MOTORPOOL USE
