**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JO-SUPPLY OF LABOR, MATERIALS & EQUIPMENT FOR THE FABRICATION AND INSTALLATION OF FAITH, HOPE, LOVE BUILDING MARKER AT OLD CITY HALL, TABACO CITY**
