A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO TABACO JOLLY FOODS CORP./JOLLIBEE FOR THE MEALS FOR THE CULMINATING ACTIVITY ON LITERACY AND NUMERACY CUM 22ND SDO FOUNDING ANNIVERSARY


