A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR THE CAPACITY BUILDING ON STRENGTHENING AND INSTITUTIONALIZING THE GAD FOCAL POINT SYSTEM
