A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF FOOD INGREDIENTS FOR INGREDIENTS FOR COMPLEMENTARY FOOD FOR 6-23 MONTHS OLD CHILDREN FOR SUPPLEMENTATION OF COMPLEMENTARY FOOD TO 6-23 MONTHS OLD CHILDREN (FEEDING SUPPLEMENTATION)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1771** with an Approved Budget for the Contract (ABC) of **Php 600,000.00**;
