#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 189 BISTRO CATERING SERVICES FOR THE MEALS & VENUE FOR THE LCW TABACO: YEAR-END EVALUATION FORUM
