A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR JO-LABOR & MATERIALS FOR THE REPAIR AND MAINTENANCE OF EVACUATION CENTER AT BRGY. RAWIS SAN MIGUEL ISLAND, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-11-1795** with an Approved Budget for the Contract (ABC) of **Php 253,619.40**;
