A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LION COMMERCIAL CORPORATION FOR THE SUPPLY & DELIVERY OF GROCERY PACK TO BE GIVEN AS TOKEN FOR LGU/GAD FAMILY WEEK AWARDS AND RECOGNITION




