**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JO-LABOR, MATERIALS, AND EQUIPMENT FOR ACTIVE TRANSPORT (BIKE LANE & BIKE RACKS) AT SEAWALL, BONTO BLVD., STO. CRISTO & SAN VICENTE ACCESS ROAD, TABACO CITY**
