A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER AND CATERING SERVICES FOR THE MEALS & VENUE FOR THE BHW CAPACITY BUILDING
