A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MEGA GREENLIFE OPC FOR THE JO-LABOR & MATERIALS FOR THE REPAIR AND MAINTENANCE OF TRUCKSCALE AND LIGHTNING ARRESTER FOR CENTRAL MRF

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-12-1820** with an Approved Budget for the Contract (ABC) of **Php 312,000.00**;
