A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE GENERAL REPAIR AND REPAINTING OF SERVICE VEHICLE WITH CONDUCTION STICKER CL-7035 (CHU)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-12-1825** with an Approved Budget for the Contract (ABC) of **Php 205,000.00**;
