A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF OUTDOOR WATERPROOF BAG FOR TABACO LGU EMPLOYEES
