A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARYED MUSIC SPORTS ZONE FOR THE SUPPLY & DELIVERY OF VARIOUS SPORTS MATERIALS AND SUPPLIES FOR SPECIAL PROGRAM IN SPORTS (SPS)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-12-1881** with an Approved Budget for the Contract (ABC) of **Php 261,350.00**;
