### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARYED MUSIC SPORTS ZONE FOR THE SUPPLY & DELIVERY OF AUDIO EQUIPMENT AND INSTRUMENTS FOR SPECIAL PROGRAM IN ARTS (SPA)

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




