A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS AND ACCESSORIES FOR VEHICLES WITH PLATE NO./CONDUCTION STICKER SNF-267 (SND-7020) AND SEH-610 AND GREENFIELD GENERATOR

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Small Value Procurement under Section 53.9 of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-12-1893 with an Approved Budget for the Contract (ABC) of Php 69,003.40;
