A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS MEDICAL AND LABORATORY SUPPLIES FOR BUNTIS DAY CARAVAN LABORATORY SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request No. 24-08-1146 with an Approved Budget for the Contract (ABC) of Php 79,940.00;
