A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE JO-LABOR, MATERIALS, AND RENTAL EQUIPMENT FOR THE CONSTRUCTION AND HARDWARE MATERIALS FOR THE IMPROVEMENT / REPAIR OF NATIONAL CHILD DEVELOPMENT CENTER AT BRGY. SALVACION, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-10-1501** with an Approved Budget for the Contract (ABC) of **Php 508,266.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
