A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF CONSTRUCTION INSTRUMENTS, TOOLS AND EQUIPMENT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement **Purchase Request No. 24-11-1534** with an Approved Budget for the Contract (ABC) of **Php 235,180.00**;
