A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF MICROSCOPE FOR FAMILY WELLNESS K-LINIK
