A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR THE REPAIR / REHAB OF 1 UNIT PATROL BOAT AT FATIMA, TABACO CITY
