A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PATIO DE SAN JOSE RESORT & CONVENTION CENTER, INC. FOR MEALS & VENUE FOR THE 2 DAY CAPABILITY DEVELOPMENT TRAINING OF CHILD DEVELOPMENT WORKERS ON RA 10821 (CHILDREN IN EMERGENCY PROTECTION ACT), DISASTER PREPAREDNESS AND FIRE PREVENTION AND EARTHQUAKE DRILL

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


