#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SCL POZO NEGRO EXCAVATOR AND PLUMBING SERVICES FOR THE JO-SIPHONING OF SEPTIC TANK SLUDGE AT BONGON HALL, TNHS, TABACO CITY
